*Dues guaranteed no increase for 4 years.

Year 1: Pay Discounted golf dues by Dec. 31, 2020 plus: (11/1/2020 to 10/31/2021 membership year)	100% Food/Beverage Credits, 25% Capital Fund and Assessment
Year 2: Pay golf dues in Black on reverse by Dec. 31, 2021 plus: (11/1/2021 to 10/31/2022 membership year)	100% Food/Beverage Credits, 50% Capital Fund and Assessment
Year 3: Pay golf dues in Black on reverse by Dec. 31, 2022 plus: (11/1/2022 to 10/31/2023 membership year)	100% Food/Beverage Credits, 75% Capital Fund and Assessment
Year 4: Pay golf dues in Black on reverse by Dec. 31, 2023 plus: (11/1/2023 to 10/31/2024 membership year)	100% Food/Beverage Credits, 100% Capital Fund and Assessment

Food credits to be billed quarterly but do not expire until October 31st

Capital Fund – All members pay Capital Fund as this money is used to maintain and purchase new equipment.

Assessment – This membership is subject to an end of year financial assessment distributed throughout the quarterly bills.
