66+:	\$250 Single \$400 Family

\* Prepay in full when submitting application for reduced fees listed in Green. These reduced rates are for first year only.

Year 1: Pay dues in GREEN on reverse plus: (11/1/2021 to 10/31/2022 membership year)	100% Food/Beverage Credits, 50% Capital Fund and Assessment
Year 2: Pay dues in Black on reverse plus: (11/1/2022 to 10/31/2023 membership year)	100% Food/Beverage Credits, 75% Capital Fund and Assessment
Year 3: Pay dues in Black on reverse plus: (11/1/2023 to 10/31/2024 membership year)	100% Food/Beverage Credits, 100% Capital Fund and Assessment

# <u>Food credits to be billed and applied for the first, Third and Fourth Quarter (November Billing, May Billing, August Billing).</u> Food Credits will expire at the end of each quarter (January, July, October).

Capital Fund – All members pay Capital Fund as this money is used to maintain and purchase new equipment.

Assessment – This membership is subject to an end of year financial assessment distributed throughout the quarterly bills the following year.
