Year 1: Pay dues in GREEN on reverse plus: (11/1/2021 to 10/31/2022 membership year)	100% Food/Beverage Credits, 50% Capital Fund and Assessment
Year 2: Pay dues in Black on reverse plus: (11/1/2022 to 10/31/2023 membership year)	100% Food/Beverage Credits, 75% Capital Fund and Assessment
Year 3: Pay dues in Black on reverse plus: (11/1/2023 to 10/31/2024 membership year)	100% Food/Beverage Credits, 100% Capital Fund and Assessment

Food credits to be billed and applied for the first, Third and Fourth Quarter (November Billing, May Billing, August Billing). Food Credits will expire at the end of each quarter (January, July, October).

Capital Fund – All members pay Capital Fund as this money is used to maintain and purchase new equipment.

Assessment – This membership is subject to an end of year financial assessment distributed throughout the quarterly bills the following year.
